

## 1. Establishing access to e-Boks for children under the age of 15

Children under the age of 15 and individuals under legal guardianship can access e-Boks by establishing access from a parent/guardian's e-Boks.

To create e-Boks and establish access from a parent/guardian's e-Boks, this form must be completed and submitted with valid documentation (see under Documentation).

Note that e-Boks does not create a new e-Boks, as the access is only established for existing users of e-Boks. The allocated access is also limited to read access and you will not be able to register senders on behalf of your child/guardianship.

When the child reaches the age of 15, he or she can be issued with NemID and will thus himself or herself have access to e-Boks with full web and mobile functionality, by accepting the terms the first time he or she logs on.

Documentation:

To be able to establish access, one of the following types of documentation must be submitted: copy of passport or national health card, as well as baptism or birth certificate and any certificate documenting the appointment of a guardian.

The form must be completed, signed and sent to e-Boks together with a copy of the chosen documentation.
